Application & Agreement for using Direct Debit Facilities at Grafton

Any member that wishes to utilise the Direct Debit membership payments MUST complete this form, as well as the Direct Debit Request Form. The renewal shall not be transacted without this completed form.

I agree that by signing this form

- I understand that I am signing up for the **full twelve months of membership** at Grafton District Golf Club in the category I have selected.
- I understand that I am liable for the full payment of this membership including any fees and charges as stated on my Invoice, and as prescribed by the Club.
- I understand that should I forfeit a payment that the Club will endeavour to contact me on the details supplied by me and that these details are true and correct, to settle the payment.
- I understand that should I have more than two forfeit payments that the full amount of the remaining membership money for the year shall be due at that time.
- I understand that the Club has the right to deduct the total amount owing from my account plus any associated fees incurred to settle the account (current rejection fee is \$5).
- I understand that should I default on payment of my obligated instalments and the Club is unable to settle the issue with me that the Club shall have the option to approach a debt collection agency to recover the money, and that my credit rating may be effected by this action.
- I understand that should I default upon payment that my membership shall be cancelled and that any monies, vouchers, or prizes allocated to me shall be forfeited to the Club.
- I understand that should I default upon payment that any Trophy or Event won by me during that year shall become null and void, to which all interpretation remain the final decision of the Match Committee, and that my name shall not appear as the winner of that event on any Club trophy, honour board or other official notice.
- I understand that by participating in this form of membership payment, I shall have all the same rights and privileges as any member, in the category I have elected to join or renewed in, as long as I am financial.

Grafton District Golf Club Direct Debit Rules and Conditions

A PROCESS TO RETAIN & ATTRACT MEMBERS TO GRAFTON DISTRICT GOLF CLUB

- 1 Members understand that by taking up this option, they are joining or renewing for a full twelve month period, or if Pro Rata they are signing up until the end of the membership season applicable each year. Members are liable for the full payment of fees and subscriptions in their selected category, and the Club has the right to debit this from the Members selected Bank Account or Credit Card (which ever option is provided by the member)
- 2 Payment deduction dates are the close of business on the 1st of each month or next business day. Grafton District Golf Club will allow up to seventy two (72) hours grace period from this period for the debit transaction to be complete. If payment has not occurred by this time, then the member is deemed to be unfinancial. All member rights and privileges shall cease and Grafton District Golf Club will refuse access to the facilities provided by the Club, including golf, practice range facilities, access to the Club as a Member, or as a Visitor. The Club may provide extensions on a case by case basis.
- 3 Should a member default on payment of their membership fees:
 - a) The Club will cancel the Membership to the Club;
 - b) The Club will add a rejection fee of \$5 to the Members outstanding monthly charge;
 - c) Any monies, vouchers or prizes allocated shall be forfeited to the Club; and
 - d) Any Trophies won during that year shall become null and void, and the members name shall not appear as the winner of that event on any Club trophy, honour board or other official notice
- 4 Should a member default on payment of their obligated instalments and the Club is unable to settle the issue with the member then the Club shall have the option to approach a debt collection agency to recover the money and associated costs, and that the members credit rating may be effected by this action.
- 5 Members understand that by signing the Direct Debit Request Form, as provided by the Club, they agree to the terms and conditions as supplied. The Member's bank statement will reflect a notification of "**Club Membership Karrinyup**".
- 6 Grafton District Golf Club reserves the right to refuse an existing or new member applying to use the direct debit facility.
- 7 A member utilising this form of membership payment shall have all the same rights and privileges as any member, in the same category they have joined or renewed in, as long as they remain financial by honouring the payments as per this agreement.
- 8 The terms and conditions of this arrangement are for the current membership year 1st October 2010 up to and including 30th September 2011 and will continue in force from year to year should the member continue their payment via direct debit.
